ORDER

AND NOW, this **18th day of June**, 2018, after a second pre-trial conference with all counsel held on the record, it is hereby **ORDERED** that the prior Pre-trial Order in the above-captioned case is **REVISED** as follows:

1. Counsel are **DIRECTED** to file all Motions *in Limine* by Wednesday, July 18, 2018. Responses to all Motions *in Limine* are due by Monday, July 30, 2018. Counsel are **DIRECTED** to notify the Court of any agreements on any Motions *in Limine* reached prior to trial to save the Court time from reviewing Motions that have been resolved.

2. Jury selection shall be conducted beginning Wednesday, August 8, 2018 to continue until a jury of 12 jurors plus 4 alternates is chosen. Counsel are **DIRECTED** to submit voir dire questions to each other on August 3, 2018 and discuss in good faith any disputes with an eye towards reaching an agreement. Counsel are **DIRECTED** to submit any remaining disputes on proposed voir dire questions to the Court by August 7, 2018. In addition, counsel are **DIRECTED** to submit to the Court a 2-3 sentence neutral summary of the case to present to the voir dire panel by August 7, 2018. If counsel cannot agree on a joint summary, they are **DIRECTED** to submit a summary individually and the Court will draft a neutral summary.

3. Counsel are **DIRECTED** to submit all deposition designations to each other by Friday, August 3, 2018. Any counsel who wish to submit counter deposition designations are **DIRECTED** to do so by Thursday, August 9, 2018.

It is **FURTHER ORDERED** that all counsel in the above-captioned matter are hereby **ATTACHED** for trial between **Wednesday, August 8, 2018 and Monday, September 24, 2018**. This attachment extends the earlier attachment that was set forth in the prior Pre-trial Order dated January 11, 2018. Court shall adjourn for a recess beginning Monday, August 27, 2018 and recommence on Tuesday, September 4, 2018.
